NOTE: Redemption/conversion cannot be processed unless original certificate(s), if issued to you are returned to us. And all units are converted into AMC electronics from CDS account. Application incomplete in any respect and/ or not accompanied by required documents are liable to be rejected or held until complete requirements are fulfilled. The cooling-off rights available only for the first time investment by an individual unit holder in a particular CIS. The Refund of every unit held by the unit holder pursuant to the exercise of a cooling off right should be an amount equal to NAV per unit applicable on the date of the cooling off right is exercised which is payable within six business days from the receipt of written request. AMC shall refund the Front end (Sales) load paid by the unit holder, however Contingent load (Back end load) will be payable by the unit holder where applicable.
