AL Habib Government Securities Fund (the Fund/ the Scheme/ the Trust/ the Unit Trust/ AHGSF) has been established in Pakistan as an Open-ended unit trust scheme under the Non- Banking Finance Companies and Notified Entities Regulations, 2008 (the “Regulations”) and registered under the Sindh Trust Act, 2020 by a Trust Deed dated December 15, 2022, entered into and between AL Habib Asset Management Limited, as the Management Company and the Central Depository Company of Pakistan Limited, as the Trustee of the Scheme.

1. Amendment in Risk Categorization:

2. Note under Authorized Investments table in clause 2.1.1:

Note under Authorized Investments table is being added in line with SECP’s Circular No: 6 of 2022 dated June 09, 2022 & read as follows:

- Considering the Moderate risk profile of the Fund, weighted average duration of portfolio of securities should not exceed Two (2) Years
